

## Notice regarding status of repurchase of own shares

Repurchase of company shares pursuant to the provisions of  
Article 165-2, the Companies Act

**Tokyo, December 1, 2011** – Kyowa Hakko Kirin announced that it has executed share repurchases in accordance with an interpretation of paragraph 156 of Japan's Companies Act and based on Article 165-3 of the Companies Act. Details as follows:

(1) Class of shares repurchased:	Common stock
(2) Period of repurchase:	November 1, 2011 to November 30, 2011 (Contract basis)
(3) Number of shares repurchased:	4,234,000 shares
(4) Total amount of repurchase cost:	3,832,110,014 yen
(5) Method of repurchase:	Purchased on the Tokyo Stock Exchange
